Manon Aubry: Stability and Growth Pact

Debate: Tuesday

The proposed reform of the Stability and Growth Pact is just a new window-dressing exercise from the Commission. Under the name of more flexibility and national ownership of debt-reduction paths, sanctions are actually strengthened and EU countries will still have to comply with the same absurd fiscal rules - to converge towards 3% deficit and 60% debt-to-GDP. As usual, this will mean cuts to public services - schools, hospitals and trains - and more unfair structural reforms undermining social security. In short, austerity is once again around the corner and people will pay the price for it. The proposal is not better at making fiscal rules fit for addressing climate change, since they do not guarantee enough fiscal leeway for states to invest massively in the green transition like they should. But what is the point of a balanced budget on a burnt planet?



Marc Botenga: EU Budget 2021- European Parliament Debate: Tuesday, Vote: Wednesday

A special fund guarantees Members of the European Parliament up to $\leq 13,700$ pension per month. That's 10 times more than most Europeans. The fund is so generous that it will go bankrupt next year, with a deficit of ≤ 300 million. And now, they expect taxpayers to step in. No way. This culture of privilege must end. Scrap the fund!



José Gusmão: EU Budget 2021- Frontex

Investigations into Frontex by the European Anti-Fraud Office and NGOs exposed systemic mismanagement and horrific practices at EU borders. The European Parliament cannot convey the message that the agency that violates human rights and that lies to MEPs deserves the most investment. Last year, we made history by not granting Frontex its 2020 budgetary discharge. This year, we must do the same.



Özlem Demirel: No EU funds for ammunition production Debate: Monday

The aim of the EU Act to Support Ammunition Production is to supply Ukraine with ammunition as quickly as possible, further fuelling the war in Ukraine. The money for this shall come from the EU budget, which is forbidden according to Article 41.2 of the EU Treaty. Money is being made available on a grand scale not only for the research and development of armaments, but also for their production and procurement. It's scandalous that the suffering of the people in Ukraine and the sympathy of the people in the EU are being shamelessly exploited to build up a military union and subsidise the EU's arms industry.



Anne-Sophie Pelletier: Protecting consumers from greenwashing Debate: Tuesday, Vote: Thursday

Greenwashing is distorted marketing. The climate emergency is more urgent than ever, we must take the necessary measures against large companies that do not respect the environment. This text is an important step towards banning programmed obsolescence and allows consumers to make informed and meaningful choices about how and what they consume.

Martina Michels: Implementation of the audiovisual media services directive

The so-called "Netflix" regulation on audio-visual services from 2018 includes videosharing platforms regarding promotion of European works, advertisement rules, protection of minors, elimination of hate speech and accessibility for people with disabilities. The Commission's evaluation on implementation in the member states was very sketchy. We are calling for further exploration of how we can maintain more cultural diversity, data transparency and how we qualify discoverability of European works.
