



Gabi Zimmer - President of GUE/NGL - Future of Europe debate with Irish PM

We are convinced that the EU will only have a future as a social and peaceful Union based on solidarity. In the debate with the Irish Taoiseach, we want to hear his demands from the EU with regards to the situation on the island of Ireland post-Brexit, as this will have repercussions on citizens' rights inside the EU as well. Abandoning neoliberal dogma and ending failed austerity policies which led to Brexit, and have brought about poverty, unemployment and more inequality to the EU is now urgent.

We have to tackle the issue of demand and ensure that perpetrators such as brothel owners, pimps and men who pay for sex are brought to justice.
